- FEDERATION REPORT
  - Dave Long advised the meeting that the Federation is very financial and are offering Grants of up to \$750 to clubs to assist with such things as hire of venues etc and grants to 'Juniors' (under 30 years of age) to support restoration projects
  - Money is raised by the Federation issuing log books, e.g. 850 in December, 4790 in January & 500 in February

## **OTHER GENERAL BUSINESS:**

- Dave Long BSAOC of SA stickers are available for all attending, please come up and get one
- Jeff Cleary check that dates for Logbook Day (31 May 2025 10.00 am -2.00 pm) and Christmas BBQ (6 December 2025) are confirmed.
  - The Mildura Meander is on soon it's a great rally, recommend going
- Dave Long will be away for the April & May meetings
- Barry Ellis advised that the order for the new BSA's coming into the country has been cancelled, could be June, July or even November now, just don't know
- Dave Long advised the General meeting that the Club Committee discussed and agreed on the proposed changes to the wording of the Constitution, in readiness for putting to the members. Below are the changed paragraphs:
  - 51. Provided that a Financial Member of the BSAOC of SA is the owner of a BSA motorcycle, which is either fully registered, or registered through the Conditional Registration Scheme for Historic, Individually Constructed, Left-Hand Drive and Street Rod Vehicles (the Scheme), then that Member may, at the Club's discretion, have other British motorcycles registered through the club, under the Scheme.

There are only spelling and grammatical changes to paragraph 52 below:

- 52. These rules amended at a General Meeting, on the 7th May 2019 to include the process taken to grant life membership to a member. 'Life membership will be appointed to a member, who has held membership for ten (10) consecutive years or more, and in the decision of the committee, having made significant contribution to the club may, be entitled to lifetime membership with the annual fees being waived.
- Howard Parslow advised the meeting that he had attended the 'All British Day' and it was a fabulous day. He wants the club to be involved next year and he will organise it.
- Verity Robertson, Rally Organiser advised the meeting that she needs someone to organise the Happy Hour at the Rally this year, as Jeff is having a well-deserved break after 5 years. Also, a Rally organiser for 2026 is needed as she is not doing the rally next year, so please consider stepping up.
- Robert Dick advised that he has still not heard from the New Zealand 2026 BSA International Rally organisers. Other members agreed that they have not heard either.
- Verity Robertson attended a Seminar on Saturday 22 February 2025 re Taxation and Not-for-Profit Associations, hosted by the Federation of Historic Motor Vehicles in conjunction with the Australian Taxation Office (ATO) at the Shedley Theatre complex, Elizabeth City Centre, on behalf of the club.

**Briefly:** The seminar was well attended by clubs from all over including the Riverland. The Seminar was opened by Hugh Davis, President of the Federation of Historic Motoring Clubs of SA Inc and Keith Mortimer from the Australian Historic Motoring Federation delivered a presentation on Governance and Risk.

Jennifer Moltisanti Assistant Commissioner ATO delivered a presentation on Not-for-Profit Associations and took many questions from the audience.

A very nice lunch was served.

# Takeaways:

- o Keeping Australian Business Number (ABN) details up to date is essential our club's details for 'authorised person' & 'authorised contacts' are up to date
- Good Governance transparency is of utmost importance which the BSAOC of SA does always.
- Reputational Risk A simple risk to a club's reputation is when a new person attends a
  meeting and isn't welcomed or looked after our club always tries to be welcoming.

## **Summary:**

- o Our Club details are up to date with its ABN requirements and contacts.
- The Seminar confirmed that our understanding of the taxation requirements re Not-for-Profit Associations is correct.
- The BSA Owners Club of SA is a 'Taxable Not-for-Profit' association and will be required to lodge a Not-for-Profit Self-Review Annual Return.
- o If the Club has a taxable income of greater that \$416 per year it must lodge a not-for-profit company tax return for that year.
- o If the Club's taxable income is less than \$416 then we are required to lodge a 'Return Not Necessary' return.
- The ATO is NOT applying compliance retrospectively it is only looking for Returns for the 2023/2024 financial year, (last financial year) onwards.
